You Have the Right to a Safe Workplace



Under federal law, every employee has the right to a safe workplace. If you believe your workplace is dangerous, you can request an inspection from the Occupational Safety and Health Administration (OSHA).

When you are injured at work, the Ohio Workers' Compensation System covers medical bills, lost wages, disability, and job retraining for employees that are injured on the job. If you are hurt at work, it's important that you report your injury to your employer immediately, along with seeking medical care. Our office assists injured workers with any claims they may have for injuries they sustain at work. If those injuries were caused by a third-party (i.e. not a coworker or your employer), you would have both a workers' comp claim and a personal injury claim.

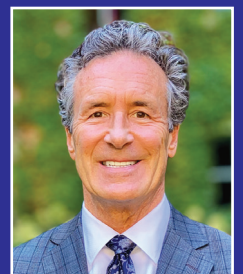
